2. Mizoram UPC Worker Endowment Policy 2009 hnuaiah Planning & Financial Board ruahmannain Mizoram UPC Pension Fund sumte chu Invest thin a ni ang.
3. Investment Policy hi 10% p.a. Simple Interest (Kumkhatah zaa sawm) pung a kalpui a ni ang.
4. Investment Rate hi India ram Economy en chungin Planning & Financial Board rawtnain Executive Committee-in a tidanglam thei ang.
5. Pawisa puk tir theitu chu Planning & Financial Board a ni ang.
6. Mizoram UPC Workers Endowment Policy 2009 Dan hmanga pawisa puk theitute chu hetiang mite hi an ni ang:
 - a) Mizoram UPC hnuaiia Pastor thawk lai confirm pastor chin chunglam.

 - b) In leh lo dinna tur ni lo thildang avang anih chuan a rulh hun chung hi kum 5 (Thla 60) a pel tur a ni lo.
 - c) Rulh zawh anih hmain a dang a puk theih lovang.
 - d) Hunbi tiam ral hmaa rulh zawh a duh anih chuan a rul zo thei ang a, a pek hun chhung milin a pung hi chhut that leh a ni ang.
 - e) Pawisa puktu pawisa rulhna chu thlatinin a hlawh l^k apianga cut/deduct siam nghal zel tur a ni.
 - f) Sum puktu hian a rulh tur a rulh zawh hmaa engemaw vanga harsatna a nei a nih pawhin a rulh tur hi a rul zo ngei tur a ni a, heng sumte hi Kohhran a\anga sum a hmuh tur a\anga siam rem a ni ang.
